AAUW Partners with the Women's Leadership Initiative

We're happy to announce that our Atlantic County branch has formally partnered with the Women's Leadership Initiative and the United Way to provide volunteer readers for the Ready, Set, Read Program.

The purpose of this reading program is to encourage young children, 6 and under, to appreciate books and reading. Volunteers select a designated preschool and childcare facility in the area and go to read to the children on dates of their own choosing. The children are then given their own copy of the book and encouraged to ask someone at home to read it to them again.

Most of the AAUW members who signed up at the September dinner meeting were able to attend the training session on Wed, Oct 23, held at the United Way offices on Jimmie Leeds Rd - under the tutelage of Dianne Lennon who oversees the program for WLI and Amanda McGowan of United Way who coordinates the reading assignments and the distribution of books.

Also attending the meeting was a representative from the Atlantic City Press, Dianne D'Amico – and on Monday, Nov 4, her article about the meeting and the program appeared in the Press. It was a very detailed account of the meeting and included quotes from several of our members as well as a photo of Audrey Owen and Pam Family looking over the children's books.

Our branch provided a good representation on Sunday afternoon, October 20th. We had 8 attendees and the total for the event was about 100 women. Two AAUW National Staff members were in charge of the event.

In a "Speed dating style rotation" of facilitators we learned about the following offerings of which AAUW National actively supports:

1. Start Smart workshops for pre college graduates/ women entering the job market. These workshops help women get a feel for the interview experience and provide opportunities for role playing situations. Negotiating for a decent salary is a major focus at these workshops.

2. Teentech & STEM programs provide hands on technology workshops for girls in grades 9, 10, & 11. Egg Harbor Township has been participating in this event held at Georgian Court University in Lakewood, NJ. It would be good to get more local school districts participating in this event and this year it will be on May 29th, 2014.

3. National AAUW is recommending that we vote for pay equity and raise the current minimum hourly wage from \$7.25 to \$8.25. By not raising the minimum wage we ensure that some women will continue living at a poverty level, need second/third jobs and food stamps indefinitely.

4. The most significant topic of the weekend however was the Human Trafficking in our state of New Jersey. Danielle Buckley, an assistant prosecutor for Atlantic County gave an excellent presentation on this subject and all of our group agreed we should have her come & do a program for our branch. If possible we need to invite local guidance counselors, and social workers to attend.

All attendees agreed it was a worthwhile event and we are returning to our branches with new avenues to explore.
