

Our **December program** is an outing to enjoy The South Jersey Area Wind Ensemble. For both our December and January programs we will be collecting gift cards for the Atlantic County Women's Center. Their needs are as follows:

Wawa gift cards for any amount are needed for the victims of domestic violence. Many of these women and their children are being sheltered and will need to pick up incidentals or buy gas.

Gift cards in \$5.00 amounts for either McDonald's or Starbucks or any other type of fast food restaurant are needed for the victims of human trafficking. When a victim is rescued, she is often hungry. The person making the rescue wants to be able to sit down with the victim to have her talk and eat. You will learn more about this at our January branch meeting, which will be a Forum on Human Trafficking.

If you are coming to the December 8^{th} dinner and program at Stockton, please bring your gift cards. You may also bring them to the January 10^{th} meeting at the Women's Center. Feel free to donate both months to assist the Women's Center in this important work. Many thanks for your support.

Due to increases in copying and postage costs, the board has approved an additional \$20 per year fee to those who receive the Forum via "Snail Mail" (mailed photocopy) which will take effect with the start of the 2015/2016 membership year. It now costs from \$1.20 to \$1.55 for copying and from \$.50 to \$.70 in postage for each copy of the Forum which gets mailed. This means that our group is expending approximately \$20 per person per year on those who receive their Forums in that manner rather than via email which costs nothing. As we only receive \$10 of your dues, this means that we are having to take an additional \$10 of hard earned operating funds to subsidize the mailings. (Remember that of your \$69 dues, \$49 goes to National, \$10 to State and only \$10 to our group.) The only alternative is to raise dues for all members which is unfair to the vast majority who read their Forums online.

If you do not have a computer or printer at home, the suggested alternatives are to go the library and use one of their computers or have a friend in our AAUW let you read it on their computer or print it out for you. The board recognizes that this may be a hardship for some of you and have delayed this decision for some time. The policy of only sending communications online has existed at the national and state levels for some time and this brings our group in to line with that policy. We apologize for any inconvenience, but our dues structure is inadequate to continue to support snail mailings of the Forum without charging those members who receive it that way.



PUBLIC POLICY UPDATE Election Day Results: How Did We Do?

On Election Day, AAUW's and friends' voices were heard loud and clear on ballot initiatives on issues including the minimum wage, paid sick days, and equal rights. Here's the rundown on how our issues fared in state elections.

Giving Workers and Women a Raise!

Voters in Alaska, Arkansas, Illinois*, Nebraska, and South Dakota strongly supported minimum wage increases. In fact, in each and every state, (red and blue) the measures received more votes than the winning candidates running statewide. Hundreds of thousands of workers will now be eligible, starting in 2015, for an hourly raise.

Since July 24, 2009, U.S. federal law requires a minimum wage of at least \$7.25 per hour. As a result of the recent election, a majority of the states have or soon will have a minimum wage higher than the federal minimum. President Obama has been advocating an increase in the amount of \$10.10 per hour. Labor activists advocate for \$15.00 per hour. An idea worth considering is to remove this issue altogether from politics (an unlikely scenario) and link the federal rate to relatively objective economic criteria such as its historical relationship to poverty or index it to inflation (as 13 states now do) Under either scenario, the minimum wage should translate to \$9.00 an hour. In New Jersey the minimum wage is \$8.25 an hour.

*Illinois' vote was nonbinding.


I'm happy to announce that this year's Boscov's Fundraiser brought in a total of **\$660.** The money will go toward a scholarship.
