#### Issues at the Forefront Linda Harmon

The April meeting provided a forum for some open discussion about issues at the forefront of AAUW. The AAUW Spring Outlook Magazine included an addendum section with new changes to the National Bylaws. These can be found in the magazine on pages E13 – E19. It has been over 10 years, but these bylaws open the door for consideration as to what is required for membership in AAUW. There are two different bylaws to vote for. On page E14, it gives consideration to allowing members **without college credentials** to be members known as **advocates**. They would pay dues, attend events, but have no voting rights nor serve as an officer or on any committee. They can attend our events **but not volunteer to help the organization**. That is the new bylaw change to Article IV 2.

Article IV 2a(1) change states, "Eligibility. An individual who pays annual dues to AAUW shall be eligible to be an active Member." (Page E15)

This brings to the forefront whether or not to allow all women, regardless of education to be members of AAUW.

You have a voice. Vote your conscience. But do vote on the new bylaws! Voting is taking place now online at AAUW.org.

#### AAUW Proposed ByLaws Amendment: Membership as an ADVOCATE

The obstacle of not having a college degree should not be another barrier women have to overcome.

Currently, there is a new way of thinking about membership in organizations; it reflects the diversity and inclusiveness that is represented in the U.S. population. AAUW diversity strategies state that no barriers to full participation on the basis of gender, race, creed, age, sexual orientation, disability, national origin, or class should exist. There are a large number of women and men who support AAUW's mission and have no college degree; their membership would enhance the organization and provide positive support for its programs and mission. This new category of membership would support the new emphasis on diversity and inclusion and broaden AAUW's community outreach, increase AAUW's recognition and eliminate yet another barrier for all women.

### Human Trafficking | AAUW Resolves to Focus, Emphasize and Act under Public Policy



The Trafficking Victims Protection Act of 2000 defines sex trafficking as the recruitment, harboring, transportation, provision, or obtaining of a person for the purposes of a commercial sex act, in which the act is induced by force, fraud, or coercion, or in which the person induced to perform such an act has not attained 18 years of age. Transportation need not be a factor.

#### The State Policy Sex Trafficking Toolkit provides:

- Provide survivor centered and trauma informed services for sex trafficking victims
- Strengthen the child welfare system's response to sex trafficking.
- Treat trafficked children as victims rather than criminals.
- End demand for the commercial sexual exploitation of children.

We have reserved 50 seats in the rear orchestra (stadium seating) with the understanding that we may need wheelchair seating and will require handicapped access to elevators. The theater said that they would recommend a wheelchair over a walker. The bus should drop us and pick us up at the front of the theater and take us to dinner. The bus and group-priced tickets will cost a total of \$145. We will have dinner together at individual cost. Each member may register a spouse or friend to accompany them. If initial seats fill, we must fill an entire second bus and be able to get 50 more tickets to take additional people.

We should leave around 10AM and arrive home at about 10:00 or 11:00 that night.

Please respond with a "yes" or "no" immediately. We will need a firm count by <u>April 28.</u> <u>2017</u> and the payment will be due by check on <u>May 22, 2017</u>. Deposits will have to be paid to the bus company and Broadway ticketing agency at that time to hold the bus and the seats for a popular time of the year for shows and travel. We will deposit the remaining funds in the AAUW account. The branch will not make any expenditures. All costs will be paid by the individuals attending.


